

ORDINANCE 80- 28

AN ORDINANCE TRANSFERRING APPROPRIATIONS WITHIN THE ROSEHILL CEMETERY FUND OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA.
