- To Adopt the Recommendations of the 1980 Sunset Review Committee Concerning the Board of Housing Quality Appeals, Environmental Quality and Conservation Commission, Parking Permit Review Board, and Telecommunications Council
- WHEREAS, Ordinance 79-88, "To Adopt a 'Sunset' Law for City Boards and Commissions" states that the Board of Housing Quality Appeals, Environmental Quality and Conservation Commission, Parking Permit Review Board, and Telecommunications Council shall terminate as of June 1, 1980; and
- WHEREAS, Ordinance 79-88 requires the Common Council to establish a Sunset Review Committee to review and evaluate each board and commission to be terminated and present its recommendations to the Council by May 1; and
- WHEREAS, the 1980 Sunset Review Committee, chaired by Councilmember Lloyd Olcott, met and made the following recommendations on the boards and commissions to be terminated; and
- WHEREAS, Ordinance 79-88 requires a majority vote of the members of the Council to continue any board or commission beyond its designated termination date;
- NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:
- SECTION I. The Board of Housing Quality Appeals shall continue in existence in full force and effect beyond the termination date of June 1, 1980 designated in Ordinance 79-88.
- SECTION II. The Environmental Quality and Conservation Commission shall continue in existence in full force and effect beyond the termination date of June 1, 1980 designated in Ordinance 79-88.
- SECTION III. The Telecommunications Council shall continue in existence in full force and effect beyond the termination date of June 1, 1980 designated in Ordinance 79-88 with the following modifications. Section 2.77.030 of the Bloomington Municipal Code, entitled "Advisory committee on community access", shall be repealed. Subsection 2.77.010(a), entitled "Telecommunications Council--Appointment--Duties", shall be amended to read as follows:
- 2.77.010 Appointment--Duties. The telecommunications council shall be composed of <u>five</u> members, such council being subject to the following conditions:
- (a) The mayor shall appoint <u>two</u> members of the council and the common council shall appoint three members. All appointments shall be for a period of two years. If a member dies or leaves the council for any other reason, a successor shall be appointed by the appropriate official or body to serve for the unexpired term for which the member had been appointed.
- SECTION IV. Section 12.16.070 of the Bloomington Municipal Code, entitled "Parking Permits--Review Board", shall be amended to terminate the existence of the Parking Permit Review Board and to read as follows:
- 12.16.070 Issuance of permits. (a) The application for a permit under the provisions of this chapter shall be submitted to the city controller who shall forward it to the city engineer. The city engineer shall approve or disapprove the application in accordance with the guidelines set forth in this chapter. An adverse ruling may be appealed to the board of <u>public works</u>, whose decision shall be final.
- (b) All permits previously issued shall become immediately reviewable upon passage of this chapter. If a previously issued permit is approved, no additional administrative fee shall be required. If a previously issued

permit is disapproved, a percentage refund based upon the months remaining in that calendar year shall be made to the permit holder upon proof of having paid the fee for that year. The board of <u>public works</u> shall further have the authority to revoke any permit upon finding violation of the regulations contained in this chapter.

SECTION V. This ordinance shall supersede any provisions in Ordinance 79-88 with which it is in conflict.

SECTION VI. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.

This ordinance adopts the recommendations of the 1980 Sunset Review Committee, which were as follows: continue Board of Housing Quality Appeals, Environmental Commission, and Telecommunications Council; terminate the Parking Permit Review Board, lower the membership of the Telecommunications Council from seven to five members; and terminate the Advisory Committee on Community Access, a body affiliated with the Telecommunications Council. To continue any of the four boards and commissions beyond the termination date of June 1, 1980 will require a majority vote of the Common Council.
