

ORDINANCE 80-35

To Amend Ordinance 79-56, "Salary Ordinance for
Police and Fire Officers and Employees", to Establish
the Base Salary for Police and Fire Pension Computations

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:


SECTION I. Ordinance 79-56 shall be amended to include a new Section VI to read as follows:

SECTION VI. For purposes of computing pension contributions from active police and fire officers and for purposes of computing pension payments to retirees and dependents of deceased retired officers, the salary of a fireman shall be considered to be the first-class fireman's salary plus fifteen years longevity as listed in this ordinance, and the salary of a policeman shall be considered to be grade 10 of an officer first class rate as listed in this ordinance.

SECTION II. Ordinance 79-56 shall be amended to renumber former Section VI to Section VII.

SECTION III. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.



SYNOPSIS

This amendment to the Police and Fire Salary Ordinance is an attempt to clarify confusing and contradictory State laws. Essentially the problem is that the rules for computing pension contributions and pension pay-outs in the law setting up the old police and fire pensions are different from the rules contained in the law setting up the new pension system.

The City, State Board of Accounts, and PERF administration had all hoped that the 1980 Legislature would deal with that confusion, but it did not. In the absence of a single, clear law, the controller is following the suggestion of the State Board of Accounts and asking the Council to clarify the City's procedures by means of this amendment.
