

ORDINANCE 80-57

To Amend Sections 15.68.120 and 15.68.130 of the  
Bloomington Municipal Code, Concerning City Parking Lots

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 15.68.120 of the Bloomington Municipal Code, entitled "Certain parking lots renamed -- Designation of new lots", shall be amended to read as follows:

15.68.120 Certain lots named--Designation of new lots. (a) The municipal parking lot located at the northwest corner of East Fourth and Dunn Streets shall be named and referred to as Municipal Parking Lot No. 1.

(b) The municipal parking lot commonly known as the Day Parking Lot located at Seventh and Walnut Streets shall be named and referred to as Municipal Parking Lot No. 2.

(c) The municipal parking lot commonly known as Kerr Parking Lot located at Fourth and Washington Streets shall be named and referred to as Municipal Parking Lot No. 3.

(d) The off-street parking lot located at Fourth and Morton Streets and situated on lots 83 and 84 of the city shall be named and referred to as Municipal Parking Lot No. 4 and shall contain not more than twenty parking meters.

(e) The off-street parking lot located at Sixth and Lincoln Streets and situated on lots 185 and 186 of the city shall be named and referred to as Municipal Parking Lot No. 5.

(f) The off-street parking lot located upon part of Fractional Outlot 20, the same being the 200 block of East Third Street, shall be named and referred to as Municipal Parking Lot No. 6 and shall contain not less than twelve parking meters.

(g) The municipal parking lot located at the southwest corner of Seventh Street and College Avenue, commonly known as the Park and Shop lot, and being situated on lots 265 and 266 of the city, shall be named and referred to as Municipal Lot No. 7.

(h) The municipal parking lot located at the northeast corner of Sixth and Morton Streets, commonly known as the Redevelopment Lot, and being situated on lots 221 and 222 of the city, shall be named and referred to as Municipal Parking Lot No. 8.

SECTION II. Section 15.68.130 of the Bloomington Municipal Code, entitled "Hourly charge--Restrictions on certain lots", shall be amended to read as follows:

15.68.130 Hourly charge--Effective times. (a) The charge for the use of all municipal parking lots shall be five cents per thirty-minute period or part thereof and ten cents per sixty minutes for the use of each space between the hours of nine a.m. and five p.m. every day except Sundays and public holidays. The charge shall be collected by parking meters, and any person parking a motor vehicle in a metered space shall deposit coins of the United States in payment.

(b) No vehicle shall park in a metered space in Municipal Lot No. 6 for more than one hour in any day when parking meters are in operation.

(c) No vehicle shall park in a metered space in Municipal Lot No. 3 for more than four hours in any day when parking meters are in operation.

SECTION III. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.



#### SYNOPSIS

This ordinance, submitted by the Traffic Commission at the request of the Council last year, would standardize the provisions on all municipal lots and provide that parking meters in all lots be effective nine a.m. to five p.m. every day except Sundays and holidays. All lots will be used for storage except the metered spaces in the Municipal Building lot and the Fourth and Washington lot which would have a one-hour limit.

The ordinance would also amend the present list of municipal lots in the Code to include the Park and Shop and the Redevelopment lots.
