

ORDINANCE 80-84

To Amend the 1981 Salary Ordinance for Appointed Officers and Employees to Authorize Continued Payment for Two New Positions in the Human Resources Dept.

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. From and after the first day of January, 1981 pursuant to IC 18-2-1-10, the following classified positions, salaries, and pay schedules for the Human Resources Department be incorporated into Sections I and II of Ordinance 80-63, Salary Ordinance for Appointed Officers and Employees of the City of Bloomington:

SECTION III. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
