ORDINANCE 79-9

Salary Ordinance for Appointed Officers and Employees, To Fix the Salary of Legal Research Assistant for the Common Council and to Delete Deputy City Clerk I from the City Clerk's Budget

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA THAT:

SECTION I. That from and after the $13\,H_{\rm h}$ day of February, 1979, the salary and pay schedule of the following appointed officer and employee of the City of Bloomington, Monroe County, Indiana, be fixed as follows:

Further, the following City of Bloomington employee position will be deleted from the 1979 Salary Ordinance (78-52) from and after February/2, 1979, and request that such position be deleted by the Common Council of said City, to wit:

SALARIED JOB RATE PAY GRADE CLASSIFICATION Deputy City Clerk I \$10,846 19

SECTION II. This ordinance shall be in full force and effect from and after its pasage by the Common Council.
