## ORDINANCE 79-58

## To Repeal Chapter 4.24 of the Bloomington Municipal Code, Entitled "Taxicabs"

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Chapter 4.24 of the Bloomington Municipal Code, entitled "Taxicabs," shall be repealed.

## SYNOPSIS

This ordinance would repeal Chapter 4.24 of the Municipal Code, which contains the rules and regulations for the operation of taxicab companies in Bloomington. The result would be that these businesses would be regulated only by the state law governing motor vehicles, which currently covers vehicle inspection and minimum insurance requirements. The sponsor of the ordinance is Councilmember Jeff Richardson.
