AN ORDINANCE TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE BY AMENDING SECTIONS 15.64.370 ENTITLED, "RESTRICTED PARKING ZONES", AND 15.64.410 ENTITLED, "NO PARKING ZONES"

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That Section 15.64.370 of the Bloomington Municipal Code, entitled, "Restricted Parking Zones", is hereby amended by adding thereto the following:

The 400 block of South College Avenue on the east side of the street, shall be designated as a 2 Hour Parking Zone.

The 300 block of South College Avenue on the East side of the street, shall be designated as a 2 Hour Parking Zone.

SECTION 2. That Section 15.64.410 of the Bloomington Municipal Code, entitled, "No Parking Zones", is hereby amended by adding thereto the following:

The North side of 12th Street between Indiana Avenue and Woodlawn shall be designated as a No Parking Zone.

SECTION 3. That this Ordinance shall be in full force and effect from and after its passage and signature in accordance with the law.

SYNOPSIS

An Ordinance to Amend the Bloomington

Municipal Code Regarding Restricted Parking

Zones and No Parking Zones

The City of Bloomington has power to make laws regarding certain aspects of parking and traffic control on its streets, and these are collected in the "Vehicles and Traffic" sections of the Bloomington Municipal Code. Consequently when parking, speed zone, or sign changes are found to be required by the Traffic Commission or other member of the City Administration, the Council must amend the code to incorporate the changes.

This ordinance makes changes in the following:

Restricted Parking Zones:

The 400 block of South College Avenue on the east side of the street, shall be designated as a 2 Hour Parking Zone.

The 300 block of South College Avenue on the East side of the street, shall be designated as a 2 Hour Parking Zone.

No Parking Zone

The North side of 12th Street between Indiana Avenue and Woodlawn shall be designated as a No Parking Zone.
