AN ORDINANCE TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE BY AMENDING SECTION 15.64.330 ENTITLED, "INTRACITY BUS STOPS", 15.72.040 ENTITLED "PARKING METERS"

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That Section 15.64.330, of the Bloomington Municipal Code, entitled, "Intracity Bus Stops", is hereby amended by adding thereto the following:

> The 100 block of South Washington Street on the West side starting at the East and West alley and running south to 4th Street shall be designated as an intracity bus stop.

SECTION 2. That Section 15.72.040, of the Bloomington Municipal Code, entitled, "Parking Meters", is hereby amended by adding thereto the following:

> The 100 block of South Washington Street on the West side starting at Kirkwood and running South to the East and West alley shall be designated as metered parking spaces.

SECTION 3. That this ordinance shall be in full force and effect from and after its passage and signature in accordance with the law.

An Ordinance to Amend the Bloomington Municipal Code

Regarding Intracity Bus Stops and Parking Meters

The City of Bloomington has power to make laws regarding certain aspects of parking and traffic control on its streets, and these are collected in the "Vehicles and Traffic" sections of the Bloomington Municipal Code. Consequently when parking, speed zone, or sign changes are found to be required by the Traffic Commission or other member of the City Administration, the Council must amend the code to incorporate the changes.

This ordinance makes change in Intracity Bus Stops as follows:

The 100 block of South Washington Street on the West side starting at the East and West alley and running south to 4th Street shall be designated as an intracity bus stop.

also change in Parking Meter Spaces as follows:

The 100 block of South Washington Street on the West side starting at Kirkwood and running South to the East and West alley shall be designated as metered parking spaces.
