#### ORDINANCE 77-73

### AN ORDINANCE TO AMEND THE BLOOMINGTON ZONING MAPS, DATED JUNE 22, 1973

WHEREAS, the Common Council of the City of Bloomington, Indiana, passed a Zoning Ordinance amendment and adopted new incorporated zoning maps on June 21, 1973, and

WHEREAS, said Zoning Ordinance and maps are now incorporated in the Bloomington Municipal Code as Title 20 of said Code, and

WHEREAS, the City Plan Commission has considered this case ZO-45-77 and recommended said Bloomington zoning maps be amended by the rezoning of certain property, and

WHEREAS, petitioner JERRY GATES requests that the Common Council of the City of Bloomington consider this petition for the rezoning of said property,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, that under the authority of Indiana Code 18-7-5-1 et seq., that the property commonly know as the S. E. corner of E. 10th Street and the 46 By-Pass be rezoned from RH, High Density Residential to BA, Arterial Business.

SECTION 1. That the unincorporated map number 7 , of June 22, 1973, be amended to rezoned the following described land as follows, to-wit:

A part of the SE 1/4 Section 34 T9N, R1W, Monroe County, Indiana, described as follows:

Beginning at the NE corner of said SE 1/4 Thence West to the R/W line of SR 46 bypass, Thence southerly on East R/W line of bypass to North R/W of Illinois Central R/R, Thence South 76<sup>0</sup> 28' East along said R/R R/W for 435.59', Thence North for 375.00' to the point of beginning. Containing 3.00 Acres.

Also a part of the SW 1/4 of Section 35, T9N, RIW, Monroe County, Indiana, described as follows:

Beginning at the NW corner of Said SW 1/4, Thence South for 375.00' to the North R/W of said R/R, Thence South  $76^{\circ}$  28' East along said R/W for 513.80', Thence North for 493.33', Thence West for 500.00' to the point of beginning. Containing 5.00 Acres.

SECTION 2. That this ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

# SYNOPSIS

#### Ordinance No. 77-73 To Amend the Zoning Maps of June 22, 1973

The Zoning Ordinance classifies all land within the planning jurisdiction into residential, business, and manufacturing zones. The boundaries for these zones are established by the Plan Commission and the Common Council and within each district only certain uses are permitted.

This ordinance, if approved, will change the zoning from RH, High Density Residential, to BA, Arterial Business at the S. E. corner of E. 10th Street and the 46 By-pass. The petitioner is Jerry Gates. Land to be used as shorping Center.
