## APPROPRIATION ORDINANCE 76-5

6.1

AN ORDINANCE SPECIALLY APPROPRIATING FROM THE FEDERAL REVENUE SHARING TRUST FUND EXPENDITURES NOT OTHERWISE APPROPRIATED OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, TO MEET THE EXTRA-ORDINARY EMERGENCY FOUND TO EXIST.

WHEREAS, certain extraordinary emergencies have developed since the adoption of the existing annual budget, so that it is now necessary to appropriate more money than was appropriated in the annual budget,

NOW, THEREFORE, to meet such extraordinary emergencies, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION I. That there be, and hereby is appropriated from the Federal Revenue Sharing Trust Fund of said City, funds not otherwise appropriated to meet the extraordinary emergencies found to exist for the expenditure of more money for the current year of 1976 than was set out in detail in the budget as finally adopted and appropriations as finally made, the following sum:

This ordinance requests appropriation from Federal Revenue Sharing for three contractual agreements between the City and organizations providing services to the City and its citizens. The requested \$4,478 for Human Resources will be used to support the Middleway House VD Clinic. The \$13,500 requested for Parks and Recreation will be used to employ a recreation planning firm to do a comprehensive update of the City's Recreation Master Plan.
