SYNOPSIS

APPROPRIATION ORDINANCE 76-19

AN ORDINANCE TO APPROPRIATE FUNDS FROM THE LOCAL ROAD AND STREET FUND

This appropriation has already been heard and passed by the Common Council; unfortunately it was subsequently denied by the State Board of Accounts on a technicality and must be passed again.

State law required that an appropriation ordinance be advertised twice, the first notice "at least ten (10) days before the meeting of the appropriating body." Because the Herald Telephone did not publish on July 5th, the ad for this appropriation first appeared on July 6th which was only nine days before the Council meeting of July 15th.

The original synopsis of the Ordinance read as follows:

Local Road and Street money is credited to the City, but cannot be drawn until several steps are taken. The City must formulate a major street project, arrange for a 10% local match, submit plans and specifications and receive approval from the Arterial Road Board, let contracts through the Board of Public Works, and appropriate the monies for the project through the City Council. All but the last step have been taken on Project # 7.

Project # 7 is the improvement of Smith Road from 3rd to 10th Streets.
