ORDINANCE NO. 75-27

AN ORDINANCE APPROVING THE PURCHASE OF CERTAIN REAL ESTATE OWNED BY MOTOR HOTEL ASSOCIATES OF INDIANA

WHEREAS, the Common Council of the City of Bloomington, Indiana, finds that certain properties owned by Motor Hotel Associates of Indiana located on Old State Highway #37 are needed for public purposes;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. The Common Council hereby approves the purchase of the following described real estate, to-wit:

A part of the Southwest quarter of Section 21, Township 9 North, Range 1 West, bounded and described as follows: Commencing at a point that is 1344.78 feet west of the southeast corner of said quarter section, said point being in the center of State Road #37; thence running North 16 degrees 30 minutes West on and along the center of said road 325.98 feet; thence continuing on and along the center of said road North 17 degrees West 197.37 feet and to the real point of beginning; thence continuing on and the center of said road North 17 degrees West 150.0 feet; thence leaving said road and running South 73 degrees West 221.86 feet; thence running North 73 degrees East 150.0 feet; thence running North 73 degrees East 221.86 feet and to the place of beginning, containing 0.76 acre, more or less.
