ORDINANCE NO. 74-61

AN ORDINANCE TO AMEND THE BLOOMINGTON
ZONING MAPS, DATED JUNE 22, 1973

WHEREAS, the Common Council of the City of Bloomington, Indiana passed a zoning ordinance amendment and adopted new incorporated zoning maps on June 21, 1973, and

WHEREAS, said zoning ordinance and maps are now incorporated in the "Bloomington Municipal Code" as Title 20 of said Code, and

WHEREAS, the City Plan Commission has recommended said Bloomington Zoning Maps be amended by the rezoning of certain property.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174 OF THE 1947 ACTS OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA AND ALL ACTS SUPPLEMENTARY AND AMENDATORY THERETO:

SECTION 1. That the incorporated map number 11, of June 22, 1973, be amended to rezone the following described land in the City of Bloomington, Monroe County, Indiana and in the two-mile fringe of the City of Bloomington from its present RS-Residential High Density, SC-Special Conservation, SC/RS, SC/RH, and SC/MG - Floodway Fringe zoning classification to an MG-General Manufacturing zone, to-wit:

Part of the Northeast quarter of Section 1, Van Buren Township, beginning at the southwest corner of said quarter section thence East 1,000 feet, thence North 1,000 feet, thence West 1,000 feet, thence South 1,000 feet to the point of beginning.

Also being described to include a portion of the Southeast quarter of Section 1, Van Buren Township beginning at the Northwest corner of said quarter section thence South 670 feet to the right-of-way of the Illinois Central Railroad thence North 530 45 minutes East along said right-of-way 1,100 feet to the North quarter section line, thence West 900 feet to the point of beginning.

SECTION 2. That this ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
