## ORDINANCE NO. 73-4

AN ORDINANCE TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE BY AMENDING SECTIONS 15.76.010, ENTITLED, "STOP INTERSECTIONS"; 15.64.400, ENTITLED, "NO PARKING ZONES"; AND 15.64.370 ENTITLED, "RESTRICTED PARKING ZONES".

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That Section 15.76.010 (1) of the Bloomington Municipal Code, entitled, "Stop Intersections" be amended by adding thereto the following:

> 1. Belle Avenue at Westwood Drive. 2. Park Square at Woodside Drive.

> 3. Middle Court at Westwood Drive.

SECTION 2. That Section 15.76.010 (2) of the Bloomington Municipal Code, entitled, "Four-Way Stop Intersections", be amended by adding thereto the following:

Seventh Street and Clark Street.
Westwood Drive and Sunset Avenue.

SECTION 3. That Section 15.76.010 (3) of the Bloomington Municipal Code, entitled, "Three-Way Stop Intersections", be amended by adding thereto the following:

Woodlawn Avenue at Southdowns Drive.
Sunset Avenue at Park Square Drive.

SECTION 4. That Section 15.64.410 of the Bloomington Municipal Code, entitled, "No Parking Zones", be amended by adding thereto the following:

> 1. The South Side of East Third Street from Walnut Street East to the first North-South Alley (distance of 183 feet).

SECTION 5. That Section 15.64.370(1) of the Bloomington Municipal Code, entitled, "Restricted Parking Zones" be amended by adding thereto the following:

1. 519 East 10th Street. . . . . . . . . . 2.

SECTION 6. That Section 15.64.370 (3) of the Bloomington Municipal Code, entitled, "One Hour Zones" be amended by adding thereto the following:

> North side of Tenth Street between Indiana Avenue and Dunn Street, with the exception of two (2) spaces at 519 East Tenth Street.

SECTION 7. That this ordinance shall be in full force and effect from and after its passage and signature in accordance with the law.
