ORDINANCE OF THE CITY OF BLOOMINGTON, COUNTY OF MONROE, STATE OF INDIANA

AN ORDINANCE TO AMEND THE BLOOMINGTON ZONING MAP, DATED JULY 13, 1967

WHEREAS, The Common Council of the City of Bloomington, Indiana, passed a zoning ordinance and adopted a zoning map on July 18, 1950, and

WHEREAS, said zoning ordinance and map are now incorporated in the "Bloomington Municipal Code" as Title 20 of said Code, and

WHEREAS, said City Zoning Ordinance includes certain contiguous unincorporated areas within a radius of two miles from the City, as shown on the map entitled "Blcomington Zoning Map II", dated July 13, 1967, and

WHEREAS, The City Plan Commission has recommended that said "Bloomington Zoning Map II", be amended by the rezoning of certain property.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174 OF THE 1947 ACTS, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA.

SECTION 1. That the map entitled "Bloomington Zoning Map II", be amended to rezone the following described land in Monroe County, Indiana from its present B-1 LIMITED BUSINESS ZONE classification to a B-3 GENERAL BUSINESS ZONE, to-wit:

A part of the South one half of Section 29, Township 9 North, Range 1 West, Monroe County, Indiana.

Beginning at a point 724.02 feet east of the mile post, thence north 249.99 feet, thence west 295 feet, thence south 249.99 feet to the section line, thence east 295 feet along said section line to thepoint of beginning. Containing 1.48 acres more or less.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
