## ORDINANCE NO. 72-54

AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND CONTIGUOUS TERRITORY

WHEREAS, the Boundary of the City of Bloomington, Indiana, is adjacent to the real estate described herein,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described land be, and the same is hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

> A part of the Southeast quarter of Section 31, Township 9 North, Range 1 West, in Monroe County, Indiana, bounded and described as follows, to-wit: Beginning at a point that is 160.31 feet west of the Southeast corner of the said Southeast quarter, thence running North a distance of 756.5 feet and to the South right-of-way line of the Bloomington Southern Railroad spur track, thence running in a Southwesterly direction over and along a curve to the left and having a radius of 1100 feet and forming the said South right-of-way line of the said Bloomington Southern Railroad spur track for a distance of 21.45 feet and to the intersection of the South right-of-way line of the main line of the I.C.R.R., thence running South 64 degrees 45 minutes West over and along the said South right-of-way line of the main line of the I.C.RR., for a distance of 410 feet, more or less, and to a point that is 576 feet West and 589 feet  $N_{0} {\rm rth}$  of the Southeast corner of the aforesaid Southeast quarter section, thence running South for a distance of 589 feet and to the South line of said quarter section, thence running East over and along the south line of said Southeast quarter section 415.7 feet, and to the place of beginning.

SECTION 2. Be it further ordained that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, promulgation, approval by the Mayor and publication in accordance with the law.
