An Ordinance concerning the annexation of adjacent and contiguous territory.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

Tract No. 1

A part of the Southeast Quarter of the Southeast Quarter of Section Three (3), Township Eight (8) North, Range One (1) West, in Monroe County, Indiana, bounded and described as follows, to-wit: Beginning at a point on the South line of said Quarter Quarter that is Five Hundred Twenty-two (522) feet West of the Southeast corner of the said Quarter Quarter; thence North Six Hundred Sixty (660) feet; thence East Two Hundred Twenty-five (225) feet; thence North Four Hundred Ninety-six and five tenths (496.5) feet; thence West Ten Hundred Thirty-Seven and one-half (1037 1/2) feet and to the West line of said Quarter Quarter; thence South over and along the West line of the said Quarter Quarter Eight Hundred Twenty-five (825) feet and to a point that is Three Hundred Thirty (330) feet North of the Southwest corner of the said Quarter Quarter; thence running East One Hundred Ninety-eight (198) feet; thence running South for Three Hundred Thirty (330) feet and to the South line of said Quarter Quarter; thence running East over and along the South line of said Quarter Quarter Fifty (50) feet; thence North Three Hundred Sixty-three (363) feet; thence East Three Hundred Eighty (380) feet; thence South Three Hundred Sixty-three (363) feet and to the South line of said Quarter Quarter; thence East over and along the South line of said Quarter Quarter One Hundred Eighty-six and one-half (186 1/2) feet, more or less, and to the place of beginning.

Tract No. 2

A part of the Southeast Quarter of the Southeast Quarter of Section Three (3), Township Eight (8) North, Range One (1) West, in Monroe County, Indiana, bounded and described as follows, to-wit: Beginning at a point on the South line of said Quarter Quarter Five Hundred Twenty-two (522) feet West of the Southeast corner thereof; thence East along Said South line One Hundred Five (105) feet; thence North parallel with the East line of said Quarter Quarter Two Hundred (200) feet; thence West One Hundred Five (105) feet; thence South Two Hundred (200) feet to the point of beginning, containing .472 acres, more or less.

Tract No. 3

A part of the Southeast Quarter of the Southeast Quarter Section 3, Township 8 North, Range 1 West, bounded and described as follows, to-wit: Beginning at a point on the South line onf said Quarter Quarter, said point being 264 feet West of the Southeast corner thereof; thence North parallel with the East line of said Quarter Quarter for a distance of 660 feet; thence East 264 feet and to the East line of said Quarter Quarter; thence North for a distance of 496.5 feet; thence West for a distance of 297 feet; thence South 1,156.5 feet and to the South line of said Quarter Quarter; thence East 33 feet and to the place of beginning, and containing 3.87 acres, more or less

SECTION 2. BE IT FURTHER ORDAINED, that the boundaries of the City of Bloomington shall be, and the same are hereby, declared to be extended so as to include all of the real estate herein above described as a part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
