ORDINANCE NO. 70-8

AN ORDINANCE TO AMEND THE BLOOMINGTON
ZONING MAP, DATED JULY 18, 1950

WHEREAS, The Common Council of the City of Bloomington, Indiana, passed a zoning ordinance and adopted a zoning map on July 18, 1950, which said ordinance and map became effective on November 17, 1950, and

WHEREAS, said zoning ordinance and map are now incorporated in the "Municipal Code of the City of Bloomington, Indiana, 1957", as Chapter 30 of said code, and

WHEREAS, The City Plan Commission has recommended that said Bloomington Zoning Map be amended by the rezoning of certain property,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174 OF THE 1947 ACTS, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the Map entitled "Bloomington Zoning Map", dated July 18, 1950, be amended to rezone the following described lot in the City of Bloomington, Monroe County, Indiana, from its present R-3 MULTIPLE DWELLING ZONE classification to a B-1 LIMITED BUSINESS ZONE, to-wit:

Part of Seminary Lot Number Fourteen (14) in the City of Bloomington, Indiana, bounded and described as follows, to-wit: Beginning at the Northwest corner of Seminary Lot Number Fourteen (14); thence running South over and along the West Line of Seminary Lot Fourteen (14) for a distance of One Hundred Four and five tenths (104.5) feet, and to the Southwest corner of Seminary Lot Fourteen (14); thence East over and along the South line of said Seminary Lot for a distance of Fifty (50) feet; thence North and parallel to the West line of said Lot for a distance of One Hundred Four and five tenths (104.5) feet and to the North line of said Lot; thence West Fifth (50) feet and to the place of beginning.


Said lands are generally located on West Second Street, West of the Monon Railroad Right of Way.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.


