ORDINANCE NO. 70-22

AN ORDINANCE TO AMEND THE BLOOMINGTON ZONING MAP, DATED JULY 18, 1950

WHEREAS, The Common Council of the City of Bloomington, Indiana, passed a zoning ordinance and adopted a zoning map on July 18, 1950, which said ordinance and map became effective on November 17, 1950, and

WHEREAS, said zoning ordinance and map are now incorporated in the "Municipal Code of the City of Bloomington, Indiana, 1957", as Chapter 30 of said code, and

WHEREAS, The City Plan Commission has recommended that said Bloomington Zoning Map be amended by the rezoning of certain property.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174 OF THE 1947 ACTS, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the Map entitled "Bloomington Zoning Map", dated July 18, 1950, be amended to rezone the following described land in the City of Bloomington, Monroe County, Indiana, from its present B-3 GENERAL BUSINESS ZONE classification to an R-4 MOBILE HOME PARK ZONE, to-witt:

Beginning at a point which is 1541.76 feet East and 463.00 feet North of the Southwest Corner of the Southeast Quarter of Section 29, Township 9 North Range 1 West, thence South 89 degrees 14 minutes 40 seconds West for a distance of 383.59 feet, thence North 01 degrees 34 minutes 35 seconds West for 572.38 feet, thence South 89 degrees 14 minutes, 40 seconds West for a distance of 124.35 feet, thence North 01 degrees 34 minutes 35 seconds West for 560.60 feet, thence North 88 degrees 49 minutes, 45 seconds East for 507.94 feet, thence South 01 degrees, 34 minutes, 35 seconds East for 1132.98 feet to the point of beginning. Containing in all 11.58 acres, more or less.

Said land is located North of Seventeenth Street near the New Bell Telephone Building.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
