ORDINANCE NO. 69-31

AN ORDINANCE TO AMEND THE BLOOMINGTON ZONING MAP, DATED JULY 31, 1967

WHEREAS, The Common Council of the City of Bloomington, Indiana, passed a zoning ordinance and adopted a zoning map in July 18, 1950, which said ordinance and map became effective on November 17, 1950, and

WHEREAS, said zoning ordinance and map are now incorporated in the "Municipal Code of the City of Bloomington, Indiana, 1957", as Chapter 30 of said code, and

WHEREAS, said zoning ordinance has been amended to include certain continguous unincorporated areas within a radius of two miles from the City, as shown on the map entitled "Bloomington Zoning Map II, dated July 31, 1967, and

WHEREAS, The City Plan Commission has recommended that said "Bloomington Zoning Map II" be amended by the rezoning of certain property.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174, OF THE 1947 ACTS, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the Map entitled "Bloomington Zoning Map II", dated July 31, 1967, be amended to rezone the following described land in Monroe County, Indiana, from its present R-1 ONE-FAMILY ZONE classification to an R-2 TWO-FAMILY ZONE, to-wit:

A part of the East half of the Southeast Quarter of Section 20, Township 8 North, Range 1 West, in Monroe County, State of Indiana, bounded and described as follows, to-wit: Beginning at the Southeast corner of the East half of the Southeast Quarter of said Section 20, Township 8 North, Range 1 West, running thence West over and along the South line of said East half of the Southeast Quarter of said Section 20, Township 8 North, Range 1 West, a distance of 105 feet, running thence North 240 feet, running thence East 105 feet and to the East line of the East half of the Southeast Quarter of said Section 20, Township 8 North, Range 1 West, running thence South over and along said East line 240 feet and to the place of beginning.

Said land is located on the North side of Church Lane between State Highway number 37 and Rogers Street.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
