## ORDINANCE NO. 69-48

AN ORDINANCE TO AMEND THE BLOOMINGTON ZONING MAP, DATED JULY 31, 1967

WHEREAS, The Common Council of the City of Bloomington, Indiana, passed a zoning ordinance and adopted a zoning map on July 18, 1950, which said ordinance and map became effective on November 17, 1950, and

WHEREAS, said zoning ordiance and map are now incorporated in the "Municipal Code of the City of Bloomington, Indiana, 1957", as Chapter 30 of said code, and

WHEREAS, said zoning ordinance has been amended to include certain continguous unincorporated areas with a radius of two miles from the City, as shown on the map entitled "Bloomington Zoning Map II", dated July 31, 1967, and

WHEREAS, The City Plan Commission has recommended that said "Bloomington Zoning Map II" be amended by the rezoning of certain property.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174, OF THE 1947 ACTS, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the Map entitled "Bloomington Zoning Map II", dated July 31, 1967, be amended to rezone the following described land in Monroe County, Indiana, from its present M-1 GENERAL INDUSTRIAL ZONE classification to an R-4 MOBILE HOME PARK ZONE, to-wit:

Part of the West half of the Northeast Quarter of Section 36, Township 9 North, Range 2 West, in Monroe County, Indiana, bounded and described as follows, to-wit: Beginning at the point on the West line of aid West Half Section where the same intersects the Southwesterly right-of-way line of the Chicago, Indianapolis and Louisville Railroad; running thence South along said West line a distance of 1188.5 feet; thence East 600 feet; thence North 400 feet; thence East to the Southwest right-of-way line of said Railroad; thence in a Northwesterly direction along said rightof-way thereof with the West boundary line of said half section and to the point of beginning, containing 14 1/2 acres, more or less.

This land is located at 900 North Curry Pike just North of Westinghouse.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
