ORDINANCE NO. 68-31

AN ORDINANCE TO AMEND THE BLOOMINGTON
ZONING MAP, DATED JULY 18, 1950

WHEREAS, The Common Council of the City of Bloomington, Indiana passed a zoning ordinance and adopted a zoning map on July 18, 1950, which said ordinance and map became effective on November 17, 1950, and

WHEREAS, said zoning ordinance and map are now incorporated in the "Municipal Code of the City of Bloomington, Indiana, 1957", as Chapter 30 of said code, and

WHEREAS, The City Plan Commission has recommended that said Bloomington zoning map be amended by the rezoning of certain property,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174, OF THE 1947 ACTS, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the Map entitled "Bloomington Zoning Map", dated July 18, 1950, be amended to rezone the following described land in the City of Bloomington, Monroe County, Indiana, from its present R-1 ONE-FAMILY ZONE Classification to an M-2 HEAVY INDUSTRIAL ZONE, to-wit:

Beginning at the Southwest point of intersection of Adams Street and West Third Street, thence running West over and along the South line of West Third Street to the Northwest corner of Lot No. 1 in Lakeview Park Addition, the same being the Northwest corner of Seminary Lot No. 140; running thence South over and along the West line of Seminary Lots No. 140, 141, 148, 149, and 156 to the North Right of Way line of State Road 45; thence Northeasterly over and along the North Right of Way line of said State Road 45 to the West line of Adams Street; thence North over and along the West line of Adams Street to the place of beginning.

EXCEPTING the North one-half of Lots 3 through 8 of Lakeview Park Addition.

This land is located on the West side of Adams Street between State Road 45 and State Road 48.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
