

ORDINANCE NO. 66-2

AN ORDINANCE TO AMEND THE BLOOMINGTON ZONING MAP, DATED JULY 18, 1950

WHEREAS, The Common Council of the City of Bloomington, Indiana, passed a zoning ordinance and adopted a zoning map on July 18, 1950, which said ordinance and map became effective on November 17, 1950, and

WHEREAS, said zoning ordinance and map are now incorporated in the "Municipal Code of the City of Bloomington, Indiana, 1957", as Chapter 30 of said code, and

WHEREAS, The City Plan Commission has recommended that said Bloomington Zoning Map be amended by the rezoning of certain property, now

THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174, OF THE 1947 ACTS, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the Map entitled "Bloomington Zoning Map" dated July 18, 1950, be amended to rezone the following described land in the City of Bloomington, Monroe County, Indiana, from its present B-1 LIMITED BUZINESS ZONE classification to a B-3 GENERAL BUSINESS ZONE, to-wit:

A part of the Southwest quarter of Section 32, Township 9 North, Range 1 West and lying West of Out Lot Number 17 in the City of Bloomington, Indiana, and described as follows: to-wit:

Beginning at the stone fence on the west end of the United Presbyterian Church Cemetery at a point 184 feet south of the northwest corner of said cemetery lot; thence west 214.5 feet; thence south 103.25 feet and to the north line of Seventh Street; thence east 214.5 feet and to the stone fence at the Southwest corner of said cemetery lot; thence north along said stone fence to the place of beginning.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
