## ORDINANCE NO. 66-26

AN ORDINANCE TO AMEND THE MUNICIPAL CODE OF THE CITY OF BLOOMINGTON, INDIANA, 1957, BY AMENDING CHAPTER 17, ENTITLED "MOTOR VEHICLES AND TRAFFIC" BY AMENDING SECTION 195 THEREOF ENTITLED "NO PARKING ZONES", SECTION 206 ENTITLED "STOP INTERSECTIONS", AND SECTION 207 ENTITLED "YIELD INTERSECTIONS."

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That Section 195 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, be amended by adding thereto the following:

- A. West Dixie Street -- on the South side of the street from the 500 block through the 700 block inclusive.
- B. West Grimes Lane -- From a point 50 feet West of Walnut Street to a point 50 feet East of the right-of-way line of the monon Railroad on the South side of West Grimes Lane, no parking shall be permitted excepting from 9:00 A.M. to 12:00 Noon and from 6:00 P.M. to 9:00 P.M. upon Sunday.

SECTION 2. That Section 206 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, be amended to include the following:

- (a) 1. Stop intersections (generally) Second Street at East side Bypass Extension.
  - 2. Stop intersections (4-way) Second and Woodlawn Streets; Second and Hawthorne Streets; First and Jordan Streets.

SECTION 3. That Section 207 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, be amended to include the following:

1. Roosevelt Street. Traffic on Roosevelt Street shall yield to traffic on East Fifth Street.

SECTION 4. This Ordinance shall be in full force and effect from and after its passage, promulgation, and publication in accordance with the law.
