AN ORDINANCE TO AMEND THE MUNICIPAL CODE OF THE CITY OF BLOOMINGTON, INDIANA, 1957, BY AMENDING CHAPTER 15 ENTITLED "LICENSES" BY AMENDING SECTION 15 ENTITLED "POOLROOM, BILLIARD ROOM, OR BOWLING ALLEY."

Be it ordained by the Common Council of the City of Bloomington, Indiana:

Section 1: That Section 15 of Chapter 15 of the Municipal Code of the City of Bloomington, Indiana, 1957, be amended to read as follows:

It shall be unlawful for any person to operate, manage or conduct within the city, for gain or profit, any pool or billiard table or bowling alley, without first obtaining a license to do so. The fee for such license shall be fifty dollars per year for the first ten tables or alleys, and five dollars for each additional table or alley so operated. In case there is a transfer of ownership or change of location, notice must be given to the Clerk-Treasurer within twenty four hours of such transfer of ownership or change in location, and a fee of one dollar paid to the Clerk-Treasurer for recording such transfer of ownership or change of location, which fees shall be paid into the general fund of the city.

A license shall be issued for a pool or billiard table or bowling alley permitting the licensee to operate the same in any room above the ground floor only with the approval of the Board of Public Works and Safety of the City, which approval shall be granted by the Board of Public Works and Safety only after an examination and approval of the premises by the Chief of the Fire Department of the City and the Chief of the Police Department of the City, providing however, that any disapproval by said Police or Fire Chief shall be presented in writing stating the reason therefor, and submitted to the Board of Public Works and Safety as a matter of record. Such approval and examination shall be required annually prior to the issuance of any license for a pool room, billiard room, or bowling alley, permitting the licensee to operate the same in any room above the ground floor.

Section 2: This Ordinance shall be in full force and effect from and after its passage, promulgation, and publication in accordance with the law.
