## ORDINANCE NO. 11, 1963

AN ORDINANCE TO AMEND THE BLOOMINGTON ZONING MAP, DATED JULY 18, 1950

WHEREAS, the Common Council of the City of Bloomington, Indiana, passed a zoning ordinance and adopted a zoning map on July 18, 1950; which said ordinance and map became effective on November 17, 1950, and

WHEREAS, the City Plan Commission has recommended that the Bloomington Zoning Map be amended by the rezoning of certain property, now

> THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174, ACTS OF 1947, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the Map entitled "Bloomington Zoning Map", dated July 18, 1950, be amended to rezone the following described land in the City of Bloomington, Monroe County, Indiana, from its present R-1 ONE FAMILY ZONE classification to a B-2 DOWNTOWN BUSINESS ZONE, to-wit;

> The area bounded on the west by Grant Street; bounded on the north by Seventh Street; bounded on the east by **J**unn Street; and bounded on the south by Sixth Street.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
