

ORDINANCE NO. 2, 1962

An Ordinance concerning the annexation of adjacent and contiguous territory pursuant to the filing of voluntary petition for annexation.

WHEREAS, the boundary of the City of Bloomington, Indiana, is along and adjacent to the real estate described herein, and

WHEREAS, the owners of a major part of the lands hereinafter described have submitted to the Common Council of the City of Bloomington, Indiana, a petition for and on their behalf for annexation of certain territory, a major portion of which the petitioners are the owners.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of the Northeast quarter of Section Three (3) and a part of the Northwest quarter of Section Two (2), Township Eight (8) North, Range One (1) West, described as follows, to-wit: Beginning at a point on the now existing corporation line, said point being Sixteen hundred Eighty-seven and One-tenth (1687.1) feet East and Twelve Hundred Thirty-three and Six-tenths (1233.6) feet South of the Northwest corner of the Northeast quarter of said Section Three (the same being Fifty-six (56) feet South of the Northwest corner of East 2nd Street and Woodscrest Drive as now laid out); thence East Fifty-six (56) feet; thence North Six (6) feet, thence South Eighty-eight degrees, Forty-seven minutes Thirty seconds East (S 88 degrees 47' 30" E) for a distance of Thirteen hundred Sixteen and Ninety-six hundredths (1316.96) feet; thence South Eighty-eight degrees, Fifty-six minutes Thirty seconds East (S 88 degrees 56' 30" E) for a distance of Eight hundred Sixty-seven (867) feet, more or less to a point on the East line of the Northwest quarter of the Northwest quarter of Section Two (2), Township Eight (8) North, Range One (1) West, said point being Twelve hundred Thirty-one and one-tenth (1231.1) feet South of the North line of said Section Two (2); thence North on and along the East line of said Northwest quarter of the Northwest quarter of Section Two (2) for a distance of Seven hundred Ninety-five and Five-tenths (795.5) feet; thence North Eighty-eight degrees, Fifty-six minutes Thirty seconds West (N 88 degrees 56' 30" W) for a distance of Two hundred Fifty (250) feet, thence North on a line parallel to the East line of said Northwest quarter of the Northwest quarter of Section Two (2) for a distance of Three hundred Ninety-five and Six-tenths (395.6) feet and to the South Right-of-Way line of State Highway Number Forty-six (46) and the existing corporation line; thence West on and along the existing corporation line, said corporation line being the South Right-of-Way line of State Highway Number Forty-six (46) and East Third Street to the West Right-of-Way line of Woodscrest Drive, thence South on and along the existing corporation line, said line being the West Right-of-Way line of Woodscrest Drive to the point of beginning.

SECTION 2. BE IT FURTHER ORDAINED, that the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
