AN Ordinance to Amend Ordinance No. 11, 1949 being an Ordinance regulating Traffic upon the Public Stbeets of the City of Bloomington, Indiana, and providing for the Administration thereof, and Providing Penalties for violations thereof.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, THAT:

Section 29A of Ordinance No. 11, 1949, entitled, "An Ordinance Regulating Traffic Upon the Public Streets of the City of Bloomington, Indiana, and Providing for the Administration Thereof, and Providing for Penalties for Violation Thereof," be amended to read as follows:

1. That there is hereby established a Bloomington Traffic Commission consisting of fifteen (15) members who shall serve without compensation.

2. The Commission shall be made up of the following ex-officio members: the City Engineer, the City Traffic Engineer, Sche City Chief of Police, the City Street Superintendent, and the Chairman of the Public Safety Committee of the Common Council; and in addition, seven (7) district members, two (2) high school representatives, one each from the University High School and the Bloomington High School, and a chairman, all of whom shall be appointed by and subject to removal by the Mayor. All members of the Bloomington Traffic Commission shall be voting members.

3. The seven districts shall be made up of the following areas of the City of Bloomington:

DISTRICT NO. 1. The area north of Third Street, west of Walnut Street, north to the City limits, and west to the city limits.

DISTRICT NO. 2. The area east of Walnut Street, west of Fee Lane, north of Tenth Street, and north to the City limits.

DISTRICT NO. 3. The area bounded by Walnut Street on the West, Tenth Street on the north, Third Street east to Indiana Avenue, north on Indiana Avenue to Seventh Street, east on Seventh Street to Woodlawn Avenue, and north on Woodlawn Avenue to Tenth Street.

DISTRICT NO. 4. That area bounded as follows, to-wit: Commencing at the intersection of Third Street and Indiana Avenue, north to Seventh Street, east to Woodlawn Avenue, north to Tenth Street, east on Tenth Street to Fee Lane, thence North on FeeLane to the city limits, and bounded on the east by the city limits and on the south by Third Street.

DISTRICT NO. 5. That area bounded on the north by Third Street, and on the east by Walnut Street, and on the south and west by the city limits.

DISTRICT NO. 6. The area bounded on the west by Walnut Street, on the north by Third Street, on the east by Woodlawn Avenue, and on the south by the city limits.

DISTRICT NO. 7, That area bounded on the north by Third Street, on the west by Woodlawn Avenue, and on the south and east by the city limits.

4. Each district member shall be a resident of the district from which he is appointed.

5. Each district representative shall appoint a district committee consisting of twelve (12) persons who are residents of the district. The district representative will hold district meetings and shall be the chairman thereof. The initial district meeting shall be held within thirty (30) days after the appointment by the Mayor, and thereafter district meetings shall be held as determined by the chairman of the district. The district representative will represent his district at all traffic commission meetings. Traffic commission meetings will be held on the 2nd Tuesday of each month at 7:30 P.M. All meetings shall be held in the Council Room of the City Hall unless otherwise designated.

6. The Bloomington Traffic Commission shall establish its own rules or prodedure which may be amended from time to time by a majority of the membership. Special meetings of the Bloomington Traffic Commission may be called by the Chairman of the Traffic Commission upon giving three (3) days' notice thereof.

7. This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
