AN ORDINANCE RATIFYING AND APPROVING THE ACTION
OF THE BOARD OF PUBLIC WORKS AND SAFETY OF THE
CITY OF BLOOMINGTON, INDIANA, IN ENTERING INTO
A CONTRACT FOR ORNAMENTAL STREET LIGHTING SERVICE
WITH PUBLIC SERVICE COMPANY OF INDIANA, INC., AN
INDIANA CORPORATION, ON THE 16th DAY OF
October, 1960.

WHEREAS, HEREBY, to-wit: On the 16th day of
August, 1960, the BOARD OF PUBLIC WORKS AND
SAFETY of the CITY OF BLOOMINGTON, INDIANA, acting for and in behalf
of said CITY OF BLOOMINGTON, entered into the following contract
for ornamental street lighting service with the PUBLIC SERVICE CO-
RPORATION OF INDIANA, INC., which said contract is in words and figures
as follows, to-wit:

WHEREAS, all acts, conditions and things precedent to the execution of the contract hereinbefore set forth have happened and been properly done in regular and due form as required by law; and

WHEREAS, said contract has been submitted by said BOARD OF PUBLIC WORKS AND SAFETY of the CITY OF BLOOMINGTON, INDIANA, to the COMMON COUNCIL of said City for its consideration and action thereon;

NOW, THEREFORE, Be It Ordained by the COMMON COUNCIL of the CITY OF BLOOMINGTON, in Monroe County, Indiana, as follows,
to-wit:

Section 1. The foregoing contract made and entered into on the 16th day of August, 1960, between the BOARD OF PUBLIC WORKS AND SAFETY of the CITY OF BLOOMINGTON, INDIANA, and the PUBLIC SERVICE COMPANY OF INDIANA, INC., be and the same is hereby in all things ratified, confirmed and approved.

Section 2. This ordinance is passed on the same day and at the same meeting at which it is introduced and it is passed by the unanimous consent of all members of the COMMON COUNCIL present, and there are present and voting at least two-thirds of the members

elect of said COMMON COUNCIL.

Section 3. This ordinance shall be in full force and effect from and after its passage.
