

ORDINANCE OF THE CITY OF BLOOMINGTON,  
 COUNTY OF MONROE, STATE OF INDIANA,  
 No. 5, 1957

An Ordinance fixing the salaries and additional compensation of the Clerk-Treasurer, City Judge, and Common Council of the City of Bloomington.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, COUNTY OF MONROE, STATE OF INDIANA:

Section 1. That from and after April 1, 1957, the annual salary of the Clerk-Treasurer of said City of Bloomington, Indiana, shall be Four Thousand Three Hundred Dollars (\$4,300.00), to be paid from the General Fund; and an additional Six Hundred Dollars (\$600.00) for acting as Clerk of the Board of Public Works and Safety of said City, to be paid from said General Fund; and in addition thereto, Six Hundred Dollars (\$600.00) additional compensation to be paid from the funds of the City Water Works of said City; also in addition thereto, Six Hundred Dollars (\$600.00) additional compensation to be paid from the funds of the Department of Sanitation or said City; all as provided by law, making a total of Six Thousand One Hundred Dollars (\$6,100.00) per year.

Section 2. That from and after April 1, 1957, the annual salary of the City Judge of said City of Bloomington, Indiana, shall be Thirty-six Hundred Dollars (\$3600.00) to which shall be added as an increase thereto the sum of Eighteen Hundred Dollars (\$1800.00) as a total annual salary of said City Judge of Fifty-four Hundred Dollars (\$5400.00), to be paid from the General Fund, as provided by law.

Section 3. That from and after April 1, 1957, the annual salary of each member of the Common Council of said City of Bloomington, Indiana, shall be Six Hundred Dollars (\$600.00) per year, to be paid from the General Fund as provided by law.

Section 4. That Sections 2, 3, and 6 of Ordinance No. 2, 1951 be, and the same hereby are, repealed effective this date.

This Ordinance shall be in full force and effect from and after its passage by the Common Council and its approval by the Mayor.
