RESOLUTION 01-11

TO APPROVE THE ECONOMIC DEVELOPMENT FINANCING AGREEMENT BETWEEN THE CITY, THE REDEVELOPMENT COMMISSION AND BLOOMINGTON LLC AND TRAVIS LLC

- WHEREAS, in 1998 Thomson Consumer Electronics ("Thomson") closed its television assembly plant in Bloomington, Indiana, eliminating 1200 jobs and leaving vacant a 200 acre, 1.8 million square foot industrial facility which is located in the Thomson Economic Development and TIF Allocation Area ("Area"); and
- WHEREAS, the site of the Thomson plant has been acquired by Bloomington LLC and related limited liability companies for redevelopment into a campus-style, high-tech business park known as the Indiana Enterprise Center, which redevelopment requires demolition of the 200,000 square foot building located at 1200 South Rogers and known as Building One; and
- WHEREAS, the Economic Development Plan for the Area was amended by the Redevelopment Commission on April 2, 2001 to allow expenditure of TIF funds from the Area for demolition of Building One; and
- WHEREAS, a Community Revitalization Enhancement District ("CREED") has been established pursuant to Ind. Code 36-7-13 upon the former Thomson site, under which Bloomington LLC may be entitled to payment of certain incremental tax revenues for attainment of goals and benchmarks on the site as approved by the Bloomington Industrial Development Advisory Commission and Common Council; and
- WHEREAS, in consideration for the expenditure of TIF funds to demolish Building One,
 Bloomington LLC has agreed to assign to the Redevelopment Commission its
 right to receive CREED revenues up to the amount paid by the Redevelopment
 Commission for the demolition; and
- WHEREAS, the Economic Development Financing Agreement between the Redevelopment Commission, the City of Bloomington, and Bloomington LLC and Travis LLC contains the terms and provisions regarding the demolition and the establishment of a benchmark upon which CREED payments to the Redevelopment Commission will be based;

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. The Common Council hereby approves the Economic Development Financing Agreement between the City of Bloomington, Indiana; the Bloomington Redevelopment Commission; Bloomington LLC; and Travis LLC and authorizes the Mayor and the President of the Common Council of the City of Bloomington to execute the agreement.

SYNOPSIS

This resolution authorizes execution by the Mayor and President of the Common Council of the Economic Development Financing Agreement between the City of Bloomington, the Bloomington Redevelopment Commission, Bloomington LLC and Travis LLC. The agreement de signates the construction of footers and foundations of the first building in the Indiana Er terprise Center as a benchmark for purposes of triggering Bloomington LLC's and Travis LI C's right to receive Community Revitalization Enhancement (CREED) funds of \$909,000, an l assigns all of Bloomington LLC's and Travis LLC's rights to such payments to the Bloomington Redevelopment Commission to reimburse it for the cost of demolishing the building located at 1200 S. Rogers.
