ORDINANCE 00-42

TO AMEND ORDINANCE 99-27
WHICH FIXED THE SALARIES OF APPOINTED OFFICERS AND EMPLOYEES OF
THE CITY OF BLOOMINGTON FOR THE YEAR 2000
(Changing Positions in the Community and Family Resources, Engineering, and Planning
Departments)

WHEREAS, the Engineering Department wishes to delete the City Engineer, the Deputy City Engineer and one of the Project Inspector positions, and replace those positions with an Engineering Services Manager and an Assistant Engineering Services Manager; and

WHEREAS, the Planning Department wishes to delete the half-time Special Projects Coordinator position and replace that position with a full-time Long Range Planner; and

WHEREAS, the Community and Family Resources Department seeks to convert the 30 hour/week Program Assistant-- Family Matters position from Temporary to Regular Part-time status this year and fund it through the department's temporary salaries budget; and

WHEREAS, each of the foregoing new job titles has been evaluated and assigned a Job Grade by the Job Evaluation Committee;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. Section 1 of Ordinance 99-27 shall be amended by deleting the following job titles, grades, and pay maximums as indicted below:



SECTION 5. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.





SYNOPSIS

This ordinance amends the Civil City Salary Ordinance for the year 2000 (Ordinance 99-27) at the request of the Engineering, Planning, and Community and Family Resources departments. In particular, the Engineering department has requested deleting the positions of City Engineer, Deputy City Engineer and one Project Inspector, and replacing those positions with an Engineering Services Manager and Assistant Engineering Services Manager. The Planning department has requested deleting the regular part-time Special Projects Coordinator position and replacing it with a regular full-time Long Range Planner. And, the Community and Family Resources department has requested the conversion of the Program Assistant – Family Matters position from a temporary to a regular part-time position. Each of these positions has a Job Title that has been reviewed and assigned a grade by the Job Evaluation Committee.

Note: On November 15, 2000 the Council adopted Amendment 1 by a vote of 3-0, which deleted references to the Project Manager position in the HAND department.
