

ORDINANCE 99-51

TO AMEND ORDINANCE 99-27
WHICH FIXED THE SALARIES OF APPOINTED OFFICERS AND EMPLOYEES OF
THE CITY OF BLOOMINGTON FOR THE YEAR 2000
Re: Positions in the Parks and Recreation and Community and Family Resources
Departments

WHEREAS, the Parks and Recreation Department proposes to keep the Assistant Golf Course Manager position, where the incumbent had planned to resign before the end of the year; and delete two Specialist positions which were intended to replace of the position of Assistant Gold Course Manager; and

WHEREAS, the Community and Family Resources Department received approval from the Council in October of 1999 to amend the 1999 Salary Ordinance adding a part-time grant-funded Program Assistant which the Department proposes to include in the 2000 Salary Ordinance;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. Section 1 of Ordinance 99-27 shall be amended by deleting the following classified positions, salary and pay schedule:


SECTION 2. Section 1 of Ordinance 99-27 shall be amended by adding the following classified positions, salary and pay schedule:

| Parks and Recreation Assistant Golf Course Manager | 5 | \$39,481 |
| Community and Family Resources Program Assistant (RPT) | 4 | \$31,053 |



SECTION 4. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.





SYNOPSIS

This ordinance amends Ordinance 99-27 which fixed the salaries for officers and employees of the Civil City by adding one position and deleting two positions in the Parks and Recreation Department and by adding one position in the Community and Family Resources Department.
