

ORDINANCE 82-46

To Amend the 1982 Salary Ordinance to Create the Position of Project Director/Childcare Services

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. From and after the ^{4th} day of August, 1982, pursuant to IC 18-2-1-10, the following classified position, salary and pay schedule for the Human Resources Department be deleted from Sections I and II of Ordinance 81-75, Salary Ordinance for Appointed Officers and Employees of the City of Bloomington:



Human Resources Specialist/Child Care Services	11,815


SECTION III. The rate shown as salary for the positions listed above is the maximum rate.

SYNOPSIS

Due to a 34% reduction in the Title XX contract for 1982-83 (beginning July 1, 1982), the Human Resources Department is re-organizing the administration of their Title XX Childcare Assistance Program. In order to maintain the same level of services, the full time positions of Project Director/Childcare Assistance Program and of Human Resources Specialist/Childcare Food Program are being combined into one 3/4 time position entitled Project Director/Childcare Services. Staff support will be provided by a 3/4 time Human Resources Specialist, while the position of Childcare Records Supervisor is being eliminated. These positions are entirely grant funded and do not require additional appropriations.
