

ORDINANCE 80-17

To Amend the 1980 Salary Ordinance for Appointed Officers and Employees-Reorganization of Rosehill Cemetery

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. That from and after the first day of January, 1980, the salary and pay schedule for the following appointed officers and employees of the City of Bloomington, Indiana, be fixed as follows:

SALARY SCHEDULE AS PRESENTED BY
MAYOR FRANCIS X. McCLOSKEY
JANUARY 1, 1980

TO THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

I, the undersigned, Francis X. McCloskey, Mayor of the City of Bloomington, Indiana, as required by IC 18-2-1-10, hereby amend the salary and pay schedule for the following appointed officers and employees of the City of Bloomington, beginning January, 1980, and continuing thereafter until duly changed, and request that such salary rate be approved by the Common Council of said City, to wit:

ROSEHILL CEMETERY

Laborer I \$4.78/hour

SECTION II. That from and after the sixth day of February, 1980, pursuant to IC 18-2-1-10, the following classified positions, salary and pay schedules for Rosehill Cemetery be deleted from Sections I and II of Ordinance 79-55, Salary Ordinance for Appointed Officers and Employees of the City of Bloomington:

SECTION III. That from and after the sixth day of February, 1980, pursuant to IC 18-2-1-10, the following classified positions, salary, and pay schedules for Rosehill Cemetery be incorporated into Sections I and II of Ordinance 79-55, Salary Ordinance for Appointed Officers and Employees of the City of Bloomington:

	Laborer II	\$ 4.98/hour

SECTION II.	<u>Pay Grade</u>	<u>Classification</u>	<u>Salary</u>
	19	Landscaper/Rosehill Sexton	\$12,000

SECTION IV. The rate shown as wages and salary for the positions listed above is the maximum rate.

SECTION V. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.

SECTION VI. PASSED and ADOPTED by the Common Council of the City of Bloomington, Monroe County, Indiana, upon this 6th day of February, 1980.



SYNOPSIS

Section one of this ordinance would amend the 1980 Salary Ordinance to correct an error made concerning the rate of pay for Rosehill Laborer I; the salary would be increased from \$4.35 to \$4.78 an hour. Sections two and three would delete the positions of Cemetery Superintendent and Secretary/Bookkeeper, create a new position, Landscaper/Rosehill Sexton, and add the position of Laborer II to the 1980 Salary Ordinance. The net result will be a savings to the City of \$7,590.
