ORDINANCE 79-28

Salary Ordinance for Appointed Officers and Employees,
To Fix the Salary of the Building Commissioner, Engineering Department

BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. That from and after the 30th day of April, 1979, the salary and pay schedule of the following appointed officers and employees of the City of Bloomington, Monroe County, Indiana, be fixed as follows:

I, the undersigned, Francis X. McCloskey, Mayor of the City of Bloomington, Indiana, as required by Indiana Code 18-1-11-1 do hereby fix the salary and create the following City of Bloomington employee position beginning April 30, 1979, and continuing thereafter until duly changed and request that such salary rate be approved by the Bloomington Common Council:
