BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON,
INDIANA:

SECTION I. That from and after the first day of January, 1975,
the salary and pay schedule for the following appointed officers
and employees of the City of Bloomington, be fixed as follows

I, the undersigned, Francis X. McCloskey, Mayor of the City

Chapter 107 of the Acts of 1959, hereby fix the salaries
and pay schedule for the following appointed officers and employees
of the City of Bloomington, Indiana, beginning February 1, 1975,
and continuing thereafter until duly changed, and request that such
salary rates be approved by the Common Council of said City to-wit:

Bus Driver-----3.74 an hour

2. DEPARTMENT OF HUMAN RESOURCES

Crisis Care Coordinator-----\$11,000 a year


Crisis Care Assistant-----\$3,200 a year

Youth Worker-----2.00 an hour

Cook-----3.00 an hour

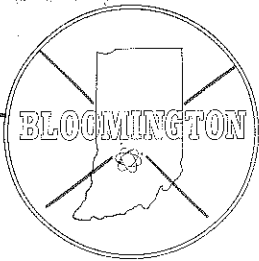
