ORDINANCE 02-06

**TO AMEND ORDINANCE 01-28
WHICH FIXED THE SALARIES OF APPOINTED OFFICERS AND EMPLOYEES OF
THE CITY OF BLOOMINGTON FOR THE YEAR 2002**

**Re: Positions in the Parks and Recreation and Planning Departments,
and in the Traffic Division**

- WHEREAS, the Parks and Recreation Department wishes to delete a Clerk/Typist position and replace it with a Customer Service Representative I position; and
- WHEREAS, the Parks and Recreation Department wishes to delete the second Clerk/Typist position, replacing it with a Customer Service Representative II position; and
- WHEREAS, the Parks and Recreation Department wishes to change the title of the Administrative Secretary position to Customer Service Representative II; and
- WHEREAS, the Parks and Recreation Department wishes to change an MEOI (104) position to Working Foreman (108); and
- WHEREAS, the Planning Department wishes to change the Secretary position to Planning Assistant; and
- WHEREAS, the Traffic Division wishes to delete the Clerk/Typist position, replacing it with the Inventory/Records Clerk position; and
- WHEREAS, each of the aforementioned new job descriptions was evaluated and assigned a Job Grade, where applicable, by the Job Evaluation Committee;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. Section 1 of Ordinance 01-28 shall be amended by deleting the following job titles, grades, and pay minimums and maximums as indicated below:


SECTION 2. Section 1 of Ordinance 01-28 shall be amended by adding the following job titles, grades, and pay minimums and maximums as indicated below:


SECTION 4. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.





SYNOPSIS

This ordinance amends the Civil City Salary Ordinance for the year 2002 (Ordinance 01-28) at the request of the Parks and Recreation Department, Planning Department, and Traffic Division. In particular, Parks and Recreation Department wishes to delete two Clerk/Typist positions (grade 1) and replace them with a Customer Service Representative I position (grade 1) and a Customer Service Representative II position (grade 2). Additionally, Parks and Recreation would like to delete an MEO I position (104), replacing it with a Working Foreman position (108), and change the title of the Administrative Secretary position (grade 2) to Customer Service Representative II (grade 2).

The Traffic Division wishes to change the title and grade of the Clerk/Typist position (grade 1) to Inventory/Records Clerk (grade 2).

The Planning Department wishes to change the title and grade of the Secretary position (grade 2) to Planning Assistant (grade 3).

Each of these positions, where applicable, have been evaluated and assigned a job grade by the Job Evaluation Committee.
