ORDINANCE 01-37

TO AMEND ORDINANCE 01-28  
WHICH FIXED THE SALARIES OF APPOINTED OFFICERS AND EMPLOYEES OF  
THE CITY OF BLOOMINGTON FOR THE YEAR 2002  
(Three Positions in the Parks and Recreation Department)

WHEREAS, the Parks and Recreation Department wishes to delete the PBA-Recreation Coordinator position and replace it with a Youth Services Program Coordinator position; and

WHEREAS, the Parks and Recreation Department wishes to delete the FSC/Youth Sports Area Manager position, replacing it with a Sports Facility Supervisor position and

WHEREAS, the Parks and Recreation Department wishes to change the title of the Adult Sports and Facilities Area Manager position to Adult and Youth Sports Manager; and

WHEREAS, each of the foregoing new job titles has been evaluated and assigned a Job Grade, where applicable, by the Job Evaluation Committee;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. Section 1 of Ordinance 01-28 shall be amended by deleting the following job titles, grades, and pay minimums and maximums as indicated below:


SECTION 2. Section 1 of Ordinance 01-28 shall be amended by adding the following job titles, grades, and pay minimums and maximums as indicated below:



SECTION 4. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.


