

ORDINANCE 00-13

**TO AMEND ORDINANCE 99-27
WHICH FIXED THE SALARIES OF APPOINTED OFFICERS AND EMPLOYEES OF
THE CITY OF BLOOMINGTON FOR THE YEAR 2000**

**Re: Positions in the Animal Shelter, Community and Family Resources, Engineering,
Information & Technology Services, and Parks and Recreation**

- WHEREAS, the Job Evaluation Committee has reviewed the amended job description for positions in Community and Family Resources, Parks and Recreation, and Rosehill Departments and has recommended changes in the grade for some of those positions; and
- WHEREAS, the Job Evaluation Committee has reviewed the amended job description for Traffic Control Specialist in the Engineering Department and has recommended changes in both the title and the grade for this position and in addition wishes to upgrade two Laborer I positions to Laborer II positions; and
- WHEREAS, the Parks and Recreation Department wishes to delete both a Park Maintenance Supervisor and Facility Maintenance Supervisor and replace both jobs with an Assistant Operations Superintendent and a Laborer II; and
- WHEREAS, the Animal Shelter wishes to add a Education Program Director; and
- WHEREAS, the Information & Technology Services Department wishes to delete a User Support and System Specialist position and add a new position of Senior User Support and System;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. Section 1 of Ordinance 99-27 shall be amended by changing the number of employees or grade and pay maximum for the following positions, as indicated below:

SECTION 3. Section 1 of Ordinance 99-27 shall be amended by adding the following job titles, grades, and pay maximums as indicated below:



SECTION 5. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.




