

ORDINANCE 99-02

TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "VEHICLES AND TRAFFIC" (Authorizing and Setting Charges for On-Street Metered Parking and Changing Limited and Public Employee Parking on North Morton Street)

WHEREAS, the Board of Public Works have recommended certain changes be made in Title 15 of Bloomington Municipal Code entitled "Vehicles and Traffic" including adding on-street metered parking spaces;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, THAT:

SECTION I. Section 15.32.090 Schedule N shall be amended to delete the following:

LIMITED PARKING ZONES

SECTION II. Section 15.32.090 Schedule N shall be amended to add the following:

SECTION III. Section 15.32.185 Schedule T shall be amended to delete the following:

SECTION IV. Section 15.32.185 Schedule T shall be amended to add the following:

SECTION V. The title for Chapter 15.40 "MUNICIPAL PARKING LOTS AND GARAGES" shall be amended to read "MUNICIPAL PARKING LOTS, GARAGES AND ON-STREET METERED PARKING" and this title shall be reflected in the Table of Contents for Title 15.

SECTION VI. Section 15.40.010 Locations (for Municipal Parking Lots, Garages and On-Street Metered Parking) shall be amended in the following manner:

- A. The phrase "The following off-street parking lots known as municipal parking lots and garages are located and identified as follows:" shall be deleted and replaced with the phrase:

The sites for off-street parking lots, which include municipal lots and garages, and on-street metered parking spaces are identified below:

- B. Item (17) shall be added to the list of sites and shall read as follows:

(17) The location of on-street metered parking spaces shall be as set forth in Schedule U.

- C. Schedule U, which is attached and made a part of this ordinance, shall be inserted at the end of Section 15.40.010.

SECTION VII. Section 15.40.020 Applicable time and charges shall be amended in the following manner:

- A. The term "Schedule U" shall be replaced with the term "Schedule V" wherever the term appears in this section and the table that follows it. (Note to codifier: Schedule U was established by Ordinance 98-52)

- B. A new paragraph (d) shall be inserted and shall read as follows:

(d) The charge for the use of each on-street metered parking space shall be five cents per twelve minutes, ten cents per twenty-four minutes and twenty-five cents per sixty minutes for the use of each on-street metered parking space between the hours of eight a.m. and five p.m., every day except Saturdays, Sundays and City holidays.

- C. The current paragraph (d) shall be changed to paragraph (e) and shall be amended to read as follows:

(e) The Board of Public Works is authorized to alter or modify the hourly charge or method of payment for parking in all municipal parking lots, garages and on-street metered parking spaces in conjunction with special events and promotional activities.

SECTION VIII. Section 15.40.030 Parking Permits shall be amended by replacing the term "Schedule U" with the term "Schedule V" wherever the term appears in that section.

SECTION IX. Section 15.40.050 Violations, part (a) shall be amended to read as follows:

- (a) No person shall permit a vehicle to remain in a metered parking space after the time limit shown upon the meter for such space has elapsed or after any restriction on the length of time a vehicle may park in a particular municipal parking lot, garage and/or on-street metered parking space has elapsed.

SECTION X. The beginning of Section 15.64.010 Violations and penalties, part (d) up to but not including part (1) shall be amended to read as follows:

- (d) Class D Traffic Violations (most parking violations)

FINE: \$12.00, \$17.00 (depending on when paid)

SECTION XI. Severability. If any section, sentence or provision of this ordinance, or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or applications of this ordinance which can be given effect without the invalid section, sentence, provision or application, and to this end the provisions of this ordinance are declared to be severable.


SECTION XII. This ordinance shall be in full force and effect on and after its passage by the Common Council and approval by the Mayor.





SYNOPSIS

This ordinance amends the Bloomington Municipal Code by authorizing and setting charges for metered parking spaces on the City's streets. The on-street metered parking spaces are located on North Morton Street and are set forth in a new Schedule U. The ordinance also changes the limited parking and public employee parking zones along North Morton Street.
