

ORDINANCE 99-07

TO AMEND ORDINANCE 98-34 WHICH FIXED THE SALARIES OF APPOINTED OFFICERS AND EMPLOYEES OF THE CITY OF BLOOMINGTON FOR THE YEAR 1999

Re: Positions in the Parks and Recreation, Parking Enforcement, Police and Sanitation Departments

WHEREAS, the Job Evaluation Committee has reviewed the amended job descriptions for certain positions in the Parks and Recreation, Parking Enforcement and Police Departments and has recommended changes in the title, grade and pay for some of those positions; and

WHEREAS, after reviewing Ordinance 98-34 the Director of Employee Services recommends restoring one position inadvertently left out of the Sanitation Department and adding one position for the Police Department recently secured through a federal grant;

NOW BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

1. Section 1 of Ordinance 98-34 shall be amended by changing the grade and pay for the following positions, as indicated below:


3. Section 1 of Ordinance 98-34 shall be amended by adding the following classified positions, salary and pay schedules:

SYNOPSIS

This ordinance amends Ordinance 98-34, which fixed the salaries for officers and employees of the City for 1999. It follows the recommendations from the job evaluation committee and raises the grade and pay for the Account Clerk position in Parking Enforcement and the Marketing Coordinator position in Parks and Recreation. Based upon those recommendations the ordinance also changes the title of the Telecommunicator position in the Police Department to Training Coordinator and raises the grade and pay. Finally, the ordinance adds a Records Clerk position in the Police Department and a Laborer I position in the Sanitation Department.
