## **SYNOPSIS**

This ordinance makes several changes to the Bloomington Municipal Code recommended by the Traffic Commission and City Engineer. These changes include stop intersections, yield intersections, signalized intersections, no parking zones, limited parking zones and loading zones. The ordinance, however, does not contain one change that was recommended by the Traffic Commission, but not supported by the City Engineer. After consultation with the Council Office, the Traffic Commission and City Engineer decided that whenever there was a disagreement on a particular recommendation, the disputed proposal would come forward as an amendment to the ordinance. In this case, the Traffic Commission requests that the Council consider Am 1, which accompanies this ordinance.

Note: Amendment 1, which inserted a new Section XI and renumbered the existing section was adopted by the Council by a vote of 6-2.
