#### **ORDINANCE 99-24**

# TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "VEHICLES AND TRAFFIC"

(Adding Municipal Parking Lots at Bryan Park and Imposing Parking Restrictions for These Lots)

- WHEREAS, Title 15 of the Bloomington Municipal Code sets forth the City of Bloomington municipal parking lots; and
- WHEREAS, Title 15 of the Bloomington Municipal Code sets forth the restrictions for parking in municipal parking lots; and
- WHEREAS, the City of Bloomington Board of Park Commissioners has voted to establish restrictions for parking in the municipal parking lots near Bryan Park;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. <u>Section 15.32.150</u>, <u>Schedule S</u>, <u>Handicapped Parking</u> shall be amended to delete reference to "Bryan Park" and the location of handicapped spaces at Bryan Park under the "public locales" section, and to add the following to the beginning of Schedule S:

Lot 17 (4 spaces) Lot 18 (1 space) Lot 19 (3 spaces)

SECTION II. Section 15.40.010 Locations shall be amended to add the following:

Lot 17: located on Woodlawn Avenue on Cummings 1<sup>st</sup> Lots 191 and 192 of the city east across Woodlawn Avenue from the Bryan Park tennis courts.

Lot 18: located on Stull Avenue on Cummings 1<sup>st</sup> Lots 45, 46, 47 and 49 of the city on the north portion of Bryan Park.

Lot 19: located on Henderson Street on Cummings 1<sup>st</sup> Lots 9, 10, 11, 12 and 13 of the city on the northwest portion of Bryan Park.

SECTION III. <u>Section 15.40.025</u> entitled "Time restrictions" shall be created and reference made to this section in the Table of Contents for Chapter 15.40. Section 15.40.025 shall read as follows:

Section 15.40.025 Time restrictions. The following parking restrictions apply to Lot 17, Lot 18, and Lot 19. Unless otherwise specifically stated below, no vehicle shall remain parked in any of these lots in excess of three (3) hours from eight a.m. to five p.m. every day, with the exception of Saturdays, Sundays and city holidays. This parking restriction shall be in effect year-round for Lot 17, and from September 1<sup>st</sup> through May 1<sup>st</sup> for Lot 18 and Lot 19. There shall be no parking permit required or time charges collected for use of the above-specified lots for this three (3) hour time period.

SECTION IV. <u>Section 15.64.010 Violations and penalties</u>, part (d) shall be amended to add the following under the "Covers" section:

Covers: 15.40.025 Parking beyond time restrictions

ECTION V. Severability. If any section, sentence or provision of this ordinance, or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or applications of this ordinance which can be given effect without the invalid section, sentence, provision or application, and to this end the provisions of this ordinance are declared to be severable.

SECTION VI. This Ordinance shall be in full force and effect on and after its passage by the Common Council of the City of Bloomington and approval by the Mayor.

#### **SYNOPSIS**

This ordinance adds five municipal parking lots at Bryan Park and creates a three-hour time restriction for vehicles parking in these municipal lots. The three-hour time restriction will apply year-round in some lots and during the school year for other lots.

Note: The Council adopted Amendment 2 by a vote of 6 - 2. It removed Lot 18 (south lot on Woodlawn Avenue by the swimming pool) and Lot 21 (south lot on South Henderson) from the ordinance and renumbered the remaining lots.

- 1. Section 1 shall be amended by deleting reference to "Lot 19," "Lot 20," and "Lot 21," and amending reference to Lot 18 to read as follows: "Lot 18 (4 spaces)."
- 2. Section 2 shall be amended by deleting references to Lot 18 through Lot 21 and inserting a new reference to Lot 18, which shall read as follows:

Lot 18: located on Henderson Street on Seminary Lots 115 and 116 of the city on the southwest portion of Bryan Park.

SECTION III. <u>Section 15.40.025</u> entitled "Time restrictions" shall be created and reference made to this section in the Table of Contents for Chapter 15.40. Section 15.40.025 shall read as follows:

Section 15.40.025 Time restrictions. The following parking restrictions apply to Lot 17 and Lot 18. Unless otherwise specifically stated below, no vehicle shall remain parked in any of these lots in excess of three (3) hours from eight a.m. to five p.m. every day, with the exception of Saturdays, Sundays and city holidays. This parking restriction shall be in effect from August 1<sup>st</sup> through November 1<sup>st</sup>. There shall be no parking permit required or time charges collected for use of the above-specified lots for this three (3) hour time period.

### **Synopsis**

This amendment would remove three parking lots from the ordinance and only regulate the parking lots by the tennis courts on Woodlawn Avenue (Lot 17) and by the new playground on Henderson Street (Lot 18). The amendment would keep the same three-hour time restrictions, but only be in effect from August 1<sup>st</sup> through November 1<sup>st</sup>.

3. Section 3 shall be amended by deleting the current provision and replacing it with the following:

SECTION III. <u>Section 15.40.025</u> entitled "Time restrictions" shall be created and reference made to this section in the Table of Contents for Chapter 15.40. Section 15.40.025 shall read as follows:

Section 15.40.025 Time restrictions. The following parking restrictions apply to Lot 17, Lot 18, and Lot 19. Unless otherwise specifically stated below, no vehicle shall remain parked in any of these lots in excess of three (3) hours from eight a.m. to five p.m. every day, with the exception of Saturdays, Sundays and city holidays. This parking restriction shall be in effect year-round for Lot 17, and from September 1<sup>st</sup> through May 1<sup>st</sup> for Lot 18 and Lot 19. There shall be no parking permit required or time charges collected for use of the above-specified lots for this three (3) hour time period.

# **Synopsis**

This amendment removes Lot 18 (by the swimming pool on Woodlawn Avenue) and Lot 21 (by the new playground equipment on South Henderson Street) from the ordinance and renumbers the remaining lots. If adopted, this amendment would allow unrestricted parking at those locations.
