RESOLUTION 99-01

OPPOSING LEGISLATION THAT WOULD PROHIBIT CONSIDERATION OF GAY AND LESBIAN CITIZENS AS ADOPTIVE OR FOSTER PARENTS

WHEREAS, legislation has been introduced in the Indiana General Assembly to prohibit homosexuals from adopting children; and

WHEREAS, recognizing that adoption is not a right and that the guiding principle must be the best interests of the child, the State of Indiana maintains careful screening procedures for potential adoptive parents, taking into account a wide range of factors including sexual orientation, with the decision ultimately requiring favorable review by a State agency as well as a judge's order; and

- WHEREAS, a recent statewide, scientific poll conducted by Indiana University's Center for Survey Research showed a large majority -- 76% -- of Hoosiers believe that decisions regarding adoption by gays and lesbians should be left to the parents and professionals involved in each case, rather than being made by State law; and
- WHEREAS, our state needs capable, loving parents to care for children who have been orphaned, neglected, or abused; and

WHEREAS, we recognize that many gay and lesbian citizens of our city and state already serve as natural or adoptive parents, and that there is no credible evidence that they are, as a group, any less capable of being good parents than heterosexuals; and

WHEREAS, the legislation being considered in the General Assembly appears to be poorly crafted and raises troubling questions, in that it leaves undefined how a potential adoptive parent may be determined by the State to be a "homosexual"; and

- WHEREAS, the legislation being considered infringes on the rights of all families to designate the best family member or other person to raise a child in the event of a birthparent's death; and
- WHEREAS, the City of Bloomington has adopted as its public policy the principle that it is wrong to discriminate against its citizens on the basis of sexual orientation, recognizing that it is unjust to deny our citizens rights or responsibilities based solely on prejudice, stereotypes, misinformation, or lack of understanding;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. The Common Council opposes and urges rejection of any proposal to bar our gay and lesbian citizens from consideration as adoptive parents.
