APPROPRIATION ORDINANCE 99-01

TO SPECIALLY APPROPRIATE FROM THE GENERAL FUND EXPENDITURES NOT OTHERWISE APPROPRIATED (Capital Outlays for the Design and Construction of a New Ice Rink)

- WHEREAS, the City of Bloomington Parks and Recreation Department ("Parks") operates the Frank Southern Ice Rink, a public ice skating facility serving the Bloomington area; and
- WHEREAS, the Frank Southern ice rink has exceeded its useful life and is in need of extensive capital expenditures; and
- WHEREAS, the cost of those capital expenditures far exceed the value of the facility, and Parks does not have the fiscal resources to fund those capital expenditures or fund the total cost of construction of a new facility or to continue to operate the existing facility; and
- WHEREAS, a consortium of community groups including Indiana University, the Ice Rink Task Force and the City of Bloomington are interested in the construction and operation of a new ice rink facility which would include public skating opportunities; and
- WHEREAS, the Common Council and Mayor committed to keep the Frank Southern Ice Rink facility open for a period of at least three years commencing with 1997;
- WHEREAS, the Common Council and Mayor committed to the Frank Southern Ice Rink facility an annual capital commitment of \$35,000 per year for a period of three years commencing with 1997 for a total not to exceed \$105,000; and
- WHEREAS, the Common Council and Mayor intend to apply any of the above funds that are not used for the Frank Southern Ice Rink facility towards the engineering, design and construction of a new ice rink; and
- WHEREAS, by this ordinance the Common Council and Mayor are committing an additional \$150,000 towards a new ice rink; and
- WHEREAS, by these actions the Common Council and Mayor intend to encourage others to join in a capital campaign that will complete the funding for a new ice rink;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. For the expenses of said municipal corporation, the following additional sums of money are hereby appropriated and ordered set apart from the funds herein named and for the purposes herein specified, subject to the laws governing the same:
