

**ORDINANCE 98-18**

**TO AMEND TITLE 15 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED  
"VEHICLES AND TRAFFIC"  
(Amending Certain Stop, Yield and Signalized Intersections;  
Parking Restrictions; and a Speed Zone)**

WHEREAS, the Traffic Commission has recommended certain changes be made in Title 15 of Bloomington Municipal Code entitled "Vehicles and Traffic;"



SECTION XI. This ordinance shall be in full force and effect on and after its passage by the Common Council and approval by the Mayor.




