

APPROPRIATION ORDINANCE 98-11

TO SPECIALLY APPROPRIATE FROM THE GENERAL FUND, MOTOR VEHICLE HIGHWAY FUND, LOCAL ROAD & STREET FUND, CUMULATIVE CAPITAL IMPROVEMENT FUND, CUMULATIVE CAPITAL EQUIPMENT (STREET CAPITAL) FUND, AND INFORMATION TECHNOLOGY SERVICES FUND EXPENDITURES NOT OTHERWISE APPROPRIATED  
 (Transfer of Funds in the Information and Technology Services Department for the Purchase of Software Licenses and Hardware; and, Reimbursements for Expenditures Related to the New Police Headquarters)

WHEREAS, the City has made expenditures for the County-wide central dispatch system; and

WHEREAS, the City has made expenditures for the improvements to the parking lot adjacent to the Police Headquarters on behalf of the Bloomington Municipal Facilities Corporation; and

WHEREAS, the City has received reimbursement from the State of Indiana and the Bloomington Municipal Facilities Corporation; and

WHEREAS, the City has determined the need to purchase current version licenses for basic software programs utilized by the City for its' personal computers;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:





SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval by the Mayor.




