ORDINANCE 97-05

TO AMEND CHAPTER 2.23 OF THE BLOOMINGTON MUNICIPAL CODE, ENTITLED "HUMAN RESOURCES DEPARTMENT" (Renaming the Human Resources Department)

WHEREAS, there have been changes in the title and responsibilities of the department formerly known as Human Resources; and

WHEREAS, various changes in the Municipal Code need to be effectuated in order to reflect said changes;

NOW THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA THAT:

SECTION 1. <u>Title 2 Administration and Enforcement, CHAPTER 2.23 HUMAN</u> <u>RESOURCES DEPARTMENT</u> shall be re-titled: <u>CHAPTER 2.23 COMMUNITY AND</u> <u>FAMILY RESOURCES DEPARTMENT</u>.

SECTION 2. <u>Section 2.23.000 Establishment--Appointment of Director</u> shall be amended to delete the word "Human" wherever it appears and to add the words "Community and Family" in its place.

SECTION 3. Section 2,23,010 Scope and Duties shall be amended as follows:

(A) Delete the words "Human Resources Department" in the first sentence and add the words "Community and Family Resources Department" in its place;

(B) Delete the word "shall" in the first sentence and add the word "may" in its place;

(C) Add the word "shall" after the word "but" in the first sentence;

(D) Delete the words "human resources" in subsection (1) and add the words "social service delivery and support" in their place;

(E) Delete the words "human resources" in subsection (2) and add the words "social" in their place;

(F) Delete the words "human resources" in subsection (3) and add the words "social service and support" in their place;

(G) Delete the words "human resources" in subsection (4) and add the words "social services" in their place;

(H) Delete the words "human resources" in subsections (5) and (6) and add the words "social service" in their place;

(I) Delete the words "human resources" in subsection (7) and add the word "social" in their place; and,

(J) Delete section (9) and renumber subsection (10) as (9).

SECTION 4. <u>Section 2.23 020 Human Resources defined</u> shall be amended in the following manner:

(A) Delete the word "Human" and add the words "Community and Family" in its place, wherever it appears in the first three lines of the section, including the title of the section;

(B) Delete subsection (1);

(C) Delete the words "handicapped and disabled citizen issues" in subsection (9) and add the words "issues affecting persons living with disabilities" in their place;

(D) Delete subsection (16);

(E) Delete the words "human resources" in subsection (18) and add the word "social" in its place;

(F) Renumber the above sections accordingly; and

(G) Reflect new section title in the Table of Contents for Chapter 2.23.

SI CTION 5. <u>Section 2.23,030 Other city human resources activities</u> shall be amended in the fo lowing manner:

(A) Delete the title and add in its place the title as follows: <u>2.23.030 Other</u> community and family resources activities;

(B) Delete the word "Human Resources" and add the words "Community and Family Resources" in its place, wherever it appears in the body of the section;

(C) Delete the word "agencies" and add the words "departments, boards and commissions" in its place wherever it appears in the first sentence of the section;

(D) Delete the second sentence in the section, which begins "Those city agencies..." ard add the following sentence in its place: "Those city departments, boards and commissions shall include, but not be limited to: the Bloomington Human Rights Commission and the Commission on the Status of Women."; and,

(E) Reflect new section title in the Table of Contents for Chapter 2.23.

SECTION 6. <u>Section 2.23.040 Human Resources Forum</u> shall be amended in the following manner:

(A) Delete the title and add the title "<u>Chapter 2.23.040 Community and Family</u> <u>Resources Forum</u>," in its place;

(B) Delete the words "Human Resources" in the first sentence of each paragraph ard add the words "Community and Family Resources" wherever they appear in each first sentence;

(C) Delete the words "human resources" in the second sentence of first paragraph at d add the word "social" in their place wherever they appear in that sentence;

(D) Delete the words 'human resources" in the third sentence of the first paragraph at d add the words "social services" in their place.

(E) Reflect the new title in the Table of Contents for Chapter 2.23.

SECTION 7. Section 2.23.050 Human Resources Commission--Establishment shall be attended in the following manner:

(A) Delete the word "Human" in the title and first sentence of the section and add the words "Community and Family" in its place wherever it appears;

(B) Delete the present second paragraph of subsection (4) and to add the following in its place:

"The Commission may review requests for financial support from the City for social services programs and activities. While the Commission is not required to review all such requests for funding, it must review those requests related to Community Development Block Grant funds. Upon completion of its review, the Commission will prepare a statement of recommendation for use by the Mayor and City Council in which may be included a recommendation that the program or activity be or not be financially supported by the City; the amount of financial support, if any, the program or activity should receive; alternative and future sources of financial support for the program or activity; and the basis of its recommendation. The Commission may review and comment on public service program elements of local community development plans and applications for block grant funding and may make recommendations to the Mayor and Common Council. It will communicate with the Redevelopment Commission when appropriate. The Commission may seek grant monies and other funds to support social services programs and activities."

; and

(C) Reflect the new title in the Table of Contents for Chapter 2.23.

SECTION 8. <u>Chapter 2.23.060</u> Commission on the Status of Women--Establishment shall be a nended to delete the word "Human Resources" and to add the words "Community and Family Resources" in its place wherever it appears in this section, except in subsection (1)(c), wherein the words "human Resources" shall be replaced by the words "social services". SECTION 9. <u>Severability</u>. If any section, sentence or provision of this ordinance, or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this section are declared to be severable.

SECTION 10. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.

SYNOPSIS

This ordinance changes the name of the Human Resources Department to that of Community and Family Resources Department. It removes their connection with the Bloomington-Monroe County Drug Commission and removes their responsibility for services connected with "artistic and cultural affairs" and with the "social impact of planning, housing development and economic development." The ordinance also rephrases the department's role in reviewing funding for social services.
